## 3 Detailed rules regarding students enrolled in Colleges of Kanazawa University taking Graduate School subject classes

(Purpose)

Article 1 These detailed rules establish the items necessary with regard to students enrolled in Colleges of Kanazawa University (hereinafter "College student") taking course subjects (hereinafter "preemptive courses") of Kanazawa University Graduate School (hereinafter "the Graduate School") in accordance with the provisions of Article 54-2 Paragraph 2 of the Kanazawa University Regulations (hereinafter "University Regulations").

(Objective)

Article 2 Preemptive courses are intended to provide opportunities for College students who excel academically and wish to enroll in Graduate School to take subject classes in the educational curriculum of the Graduate School while also connecting their current education with Graduate school education.

(Course qualifications)

- Article 3 A person who falls under both of the following items shall be a person who may take preemptive courses.
  - (1) A person in his or her final year of study in a College who wishes to enroll in Graduate School
  - (2) Those who meet the criteria set by the Graduate School for academic excellence
- 2 In addition to those described in the preceding Paragraph, the Dean of the Graduate School may approve the courses for those deemed particularly necessary.

(Courses)

- Article 4 Subject classes that can be taken as preemptive courses are defined by the Graduate School as preemptive course classes.

  (Course credit limit)
- Article 5 The number of credits that can be taken as preemptive course subject classes shall not exceed 10 credits among the subject classes specified by the Graduate School in which the student wishes to enroll.

(Applying for courses)

Article 6 A student who wishes to take preemptive courses (hereinafter "student who wishes to take preemptive courses") must submit the Application to Enroll in Graduate School Preemptive Subject Classes (Attached Form 1) to the Dean of the College with which he or she is affiliated (hereinafter "Dean of College") by the prescribed deadline.

(Permission to take courses)

- Article 7 If the Dean of College finds that the application of the student who wishes to take preemptive courses described in the preceding Article is educationally beneficial to the student and does not interfere with his or her curriculum of study, the Dean of College may submit a recommendation to the relevant Dean of the Graduate School along with the prescribed documents for the Application to Enroll in Graduate School Preemptive Subject Classes described in the preceding Article.
- 2 The Dean of the Graduate School shall decide the subject classes that may be taken as preemptive courses and notify the student who wishes to take preemptive courses of the relevant results through the Dean of College via the Notice of Registration Notification of Enrollment in Graduate School Preemptive Subject Classes (At-

tached Form 2).

(Grade management)

- Article 8 The Graduate School shall properly manage course evaluations for preemptive course subject classes.
- Article 9 Credits earned from preemptive courses are deemed to have been earned from subject classes taken at the Graduate School only when the student who wishes to take preemptive courses enrolls in the Graduate School, and the credits earned may be recognized as credits required for completion of the curriculum of Kanazawa University Graduate School, as determined by the Graduate School.
- 2 Credits earned from taking preemptive courses cannot be included in the credits earned from the College to which the student is affiliated.
- 3 The number of credits from subject classes taken as preemptive courses shall not be included in the calculations of the maximum limit of the number of credits that can be registered as courses stipulated in article 54 of the University Regulations.

(Miscellaneous)

Article 10 Matters necessary for preemptive courses in addition to these detailed rules shall be provided for separately by the Colleges and Graduate Schools.
